Cleaning Up the Everglades, One Trail at a Time

On March 22, 2008, Chen and Associates employees volunteered in the Florida Everglades west of Homestead. Two park rangers lead employees through the park to explain the environmental issues created by invasive plant species in the park and how they are being addressed. 


